Each relay will fire sighting shots, view sighting targets and fire 30 rounds for record. as below. Competitors will score and replace targets upon firing the entire match on one target set.

Target: NRA SR-1 Target will be used for all stages.

Stages:

- Sighting Stage: 5 shots, any position, 5 minutes time limit.
- Stage 1 Prone: Slow Fire 10 Shots Prone, 10 minutes, Single Load
- Stage 2 Prone: Rapid Fire 10 shots, Prone, 80 Seconds, starting from Prone Position, loaded 2 and 8 or 5 and 5 rounds. Magazine Change required. Hunting rifles may load 4 and 4 rounds, 32 seconds for each string, firing 8 rounds for record.
- Stage 3 Standing: Slow fire, 10 shots, Single Load.

Alibis: No re-fires will be allowed.

Equipment: Eye and Ear Protection, Safety Flag. Pen or pencil, stapler, and staples.

Also Useful: Spotting Scope or binoculars, ground pad, elbow pad, glove for non-firing hand, rifle sling, Coat or jacket, visored hat, Water, bug dope, sunscreen.

Duties: Competitors will be asked to move down range to score and replace targets, set up and restow target frames please.
