Rules: Current NRA High Power rules and NRA F-Class Rules will govern. Open Bolt Indicator, Hearing and Eye

Protection are required!

**Eligibility:** Open to any ARC member. Non-ARC members must pay \$5 one-day membership fee.

Pre-Register: For base personnel safety, JBER Public Affairs requires ALL competitors to have a DoD ID, or to be added

to the list of planned participants at the beginning of the season, or contact the match director two weeks prior to the event to be background checked and added to list of cleared participants. Additionally, participants are required to pre-register beginning 2 weeks prior to the match, utilizing the link on the clubs' website <a href="https://akrifleclub.com/schedule/">https://akrifleclub.com/schedule/</a>. Walk-on participants cannot be accommodated if they have not

met the Public Affairs requirements.

Fees: Tournament Fee - \$15. Non-ARC members pay \$20. (Shooters under 18 are free).

**Entries Due:** 5:00 PM – 5:45 PM

**Start Times:** Firing commences. 06:00 PM

**Squadding:** Squadding assignment for individual matches will be issued during registration.

Classification The NRA Mid-Range Prone Classifications will apply. Unclassified competitors will compete in the Master

Class. Assigned Classification (Rule 19.6), or Temporary Classification (Rule 19.2), may be used. **Scores** 

shot in this League match will be submitted to the NRA at the end of the season.

**Targets:** 600 yard MR-1 and MR-1FC targets. Shotmarker electronic target systems will be used (Rule 10.17). Club

provides tablets for shooters and scorers. In the event of a failure of the target systems, pulling targets in

the pits will be required.

Rifles: Mid-Range Prone: Service Rifle (Rule 3.1), Any Rifle (Rule 3.2), NRA Match Rifle (Rule 3.3) Palma Rifle

(Rule 3.3.1)

Mid-Range Tactical Rifle: NRA Mid-Range (Prone) Tactical Rifle (AR) (PROVISIONAL – Rule 3.3.3)

F-Class: F-Class Open Rifle (F-O) (Rule 3.4(a)), F-Class Target Rifle (F-TR) (Rule 3.4(b)).

F-Club: Rifles using muzzle brakes or suppressors or otherwise not compliant with NRA F-Class rifle rule.

Scores not submitted to NRA but still eligible for awards if fired from prone position.

Course of Fire:

**Match A:** Four sighting shots and 20 shots for record in 22 minutes prone slow fire at 600 yards.

Classes: NRA Mid-Range Prone Classifications will apply.

**F-Class** F-Class shooters will fire the same course as the HP Mid-Range shooters, only they will use the F-Class

targets at each distance and will fire either F-Open, F-TR or F-Club against other F-Class shooters only.

Awards: No awards, but results for the match will be posted on the club website, grouped by Rifles: Prone, Tactical

Rifle and F-Class
