

## 2026 NRA High Power Rifle BRSP 100yd League

- Capacity:** Maximum competitors: 16
- Dates:** Mondays April 20, May 4, May 18, June 1, 2026
- Location:** Birchwood Recreation and Shooting Park
- Sponsor:** Alaska Rifle Club co-hosted by Birchwood Recreation and Shooting Park
- Directions:** Traveling North from Anchorage, take the North Birchwood exit. Go West toward Cook Inlet. Shortly after crossing the railroad tracks, turn right at the Birchwood Recreation and Shooting Park entrance. Check in at the clubhouse then go south to the Rifle Ranges.

- Rules:** [Current NRA High Power rules](#) will govern. Open Bolt Indicator, Hearing and Eye Protection are required!
- Eligibility:** Open to all in accordance with NRA rule 2.
- Pre registration:** Please register at <https://brspclub.clubautomation.com/>. Walk on competitors will be squadded in a first come first served basis after signing up at the BRSP clubhouse.
- Fees:** Tournament Fee: \$10 for BRSP members, \$25 for non-BRSP members.
- Entries Due:** Range opens 17:30. Entries close and safety briefing starts at 17:30. If you can arrive at 17:00 to help with range setup that would be much appreciated!
- Start Times:** Shooting will start at 18:00
- Squadding:** Squadding assignment will be issued at the range after signing in at clubhouse.
- Classification:** The NRA classification system will be used. Unclassified competitors will compete in the Master Class. Assigned Classification (Rule 19.6), or Temporary Classification (Rule 19.2), may be used.
- Scores shot in this League match will be submitted to the NRA after last match in June.**
- Rifles:** NRA Service Rifle-Rule 3.1 – may have an optical sight (reflective sights are considered optical sights) with a maximum power of 4.5X and a maximum objective lens of 34mm. The Service Rifle may be equipped with issue-type metallic front and rear sights.  
Any Rifle-Rule 3.2 or NRA Match Rifle-Rule 3.3 - may have any type of sights, metallic or telescopic.
- Ammunition:** Competitors may use any ammunition that is safe to shoot. Remember safety is the responsibility of everyone. None of us wish to endanger ourselves or other competitors on the line.
- Targets:** 100 yd reduced Targets, SR-1, SR-21, and MR-31.  
Competitors will be required to score targets for other competitors.
- Sighters:** Sighting shots (Rule 9.2), which are allowed in the conditions for each match may be taken and recorded. Sighting shots may be taken in a position other than specified for the match, but must be one of those described in Rule 5 of the High Power Rifle Rule Book, except 5.13.

### Course of Fire

- Match 1:** 2 sighting shots and 10 shots for record, standing, slow fire, 100 yards, SR-1 target.
- Match 2:** 2 sighting shots and 10 shots for record in 60 sec, sitting or kneeling, 100 yards, SR-1 target.
- Match 3:** 2 sighting shots and 10 shots for record, prone in 70 sec, 100 yards, SR-21 target.
- Match 4:** 2 sighting shots and 20 shots for record, prone, slow fire, 100 yards, MR-31 target.

**Match 5:** Aggregate of scores from matches 1-4

**Awards:** No cash awards but results for the match will be posted on the club website, grouped by Rifle category.
